Procedure for sanction of NH (O) works and monitoring systems- Amendment for works being executed through BRO- Reg.

Sir.

The undersigned is directed to invite reference to this Ministry's letter of even number dated 19.08.2008 on the above mentioned subject and to intimate that the existing procedure for sanction of NH works being executed through BRO has been reviewed keeping in view the fact that allocation of funds to BRO for NH works are presently being made by Ministry of Defence (MoD) under MH 5054 (Plan). Further, a proposal in this context has also been received from DGBR vide note no. 41543/DGBR/TECH POL/GEN/West, dated 27.07.2016.

- 2. In view of the above, it has been decided that following procedure may, henceforth, be followed regarding sanction of NH works being implemented by BRO for which funds are provided through MoD budget with immediate effect.
 - 2.1. The Annual Plan for the works to be taken up by BRO under NH may be got prepared and approved by DGBR under intimation to this Ministry.
 - 2.2. This Ministry shall accord Technical Approval / Sanction for the NH works being implemented through BRO as per the extant delegation of powers in the Ministry.
 - 2.3. The Administrative Approval and Financial Sanction (AA&FS) for the works, for which funds are provided by MoD, may be accorded by the Competent Authority in MoD.
 - 2.4. The above procedure may, also, be followed henceforth for sanction of Revised Cost Estimates for such NH works, including proposals pertaining to grant of extension of time for ongoing works having additional financial implications over sanctioned provisions.
- 3. The above procedure for sanction of works shall not, however, be applicable for the works under SARDP-NE scheme including Arunachal Pradesh Package of Roads for which the Ministry earmarks Budgetary Allocation to BRO. For these works, the procedure stipulated vide letter of even number dated 19.08.2008 and extant procedure for SARDP-NE scheme shall continue to be followed.
- 4. This issue with the concurrence of Finance Wing vide U.O. No. 2360/TF-II dated 16.09.2016 and approval of Competent Authority.
